**Position Summary:** The Maintenance Worker for Healthcare Facilities is responsible for performing a variety of maintenance and repair tasks to ensure the proper functioning and safety of healthcare facilities. This role requires a versatile skill set in maintenance disciplines, a commitment to quality, and an exceptional degree of professionalism due to the sensitive nature of the healthcare environment.

## Essential Duties and Responsibilities include the following, but are not limited to:

- Perform routine maintenance tasks such as changing light bulbs, repairing doors, painting, plumbing fixes, and electrical installations.
- Under the direction of the Facilities Manager repair interior and exterior features that may require knowledge in electrical, plumbing, and carpentry.
- Respond to emergency maintenance requests promptly and efficiently.
- Conduct regular inspections of facility infrastructure to identify and resolve issues.
- Ensure compliance with healthcare industry standards, regulations, and safety protocols while performing tasks.
- Coordinate with the Facilities Manager and healthcare staff to prioritize and schedule maintenance activities without disrupting patient care.
- Keep inventory of maintenance supplies and equipment; inform the Facilities Manager when restocking is needed.
- Document completed tasks, time spent, and materials used, for tracking and billing purposes.
- Work with other facility personnel such as cleaners and security staff to ensure a safe and operational environment.

- Vocational training and general proficiency in electrical, plumbing, carpentry, and painting tasks.
- Basic understanding of healthcare compliance and regulations.
- Strong problem-solving skills and attention to detail.
